IARC Monograph No 93 reports that there is sufficient evidence of carcinogenicity in experimental rats exposed to high concentrations of titanium dioxide dust but inadequate evidence for carcinogenicity in humans and has assigned a Group 2B rating. In addition the IARC summary concludes, "No significant exposure to titanium dioxide is thought to occur during the use of products in which titanium dioxide is bound to other materials, such as paint."
